HAZRAT SHAHJALAL INTERNATIONAL AIRPORT (HSIA), DHAKA
ON PUBLIC PRIVATE PARTNERSHIP BASIS**

Government Objectives: The Government of the People's Republic of Bangladesh ("GoB") aims to implement the project named "Supply, Installation and Commissioning of a Multi Mode Surveillance System (Radar, ADS-B Wide area Multilateration-WAM) along with ATC and Communication system at Hazrat Shahjalal International Airport (HSIA), Dhaka" to enhance the Air Navigation Services of Bangladesh. GoB has resolved to develop the Project on Public Private Partnership ("PPP") basis.

Description of the Project: The selected private sector partner will collaborate with GoB and will be responsible for the design, procurement, installation and commissioning of the equipment, financing, maintenance and operations of the said project for a specific period as set out in the concession agreement.

Next Steps & Deadline: Civil Aviation Authority of Bangladesh, on behalf of GoB, now requests Registration of Interest ("ROI") from prospective developers or consortia of prospective developers interested in the development and operation of the said project. Interested parties are requested to submit the following:

- Scope of equipment and civil infrastructure that may be required for the project;
- Likely challenges for the private developer and the desired support required from CAAB for successful implementation of the project;
- General information about the prospective developer;
- Description of the prospective developer's activities in participating in similar projects in the most recent five years; and
- Copies of the two most recent audited financial statements.

Interested parties may provide additional information considered relevant including their brochures and/or corporate literature. Registration of interests must be made latest by 30 April 2014, and no later than 5.00 PM Bangladesh Standard Time (BST) by email (not exceeding 5 MB) with subject line "Supply, Installation and Commissioning of a Multi Mode Surveillance System (Radar, ADS-B Wide area Multilateration-WAM) along with ATC and Communication system at Hazrat Shahjalal International Airport (HSIA), Dhaka" and addressed to:
