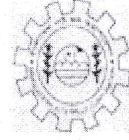


Interested bidders may submit their Bids in response to this IFB notice. Details of the Project, Bid submission process and other requirements have been set out in the IFB document.
