Dear Mr Azad

I refer to our recent telephone conversations and emails. In view of the challenges, we agreed that the workshop demonstrating multiple e-government solutions will take place on 26 May 2025.

We understand from the office of the Chief Advisor that you are expecting to see some kind of presentation from us in advance of the workshop. I stress that the workshop will demonstrate specific e-government technology solutions, and we will bring technical experts from China to demonstrate each solution. We therefore do not anticipate sending you any further presentation at this point.

We anticipate that our presentation will take approximately 2.5 hours and we shall have 20 participants from the departments and bodies in the Annex. We request you please invite these bodies; as a foreign company, we are not fully cognizant of the operational structures of these authorities and the responsible officials. We suggest that you write to the head of the relevant organization requesting him/her to select the most relevant person. We request that the ICT Ministry be invited to the workshop as a key stakeholder; also, as some of the solutions to be discussed are core to security of the state (e.g. National ID/ Voter ID systems) we would request that key organizations involved in national security are also invited to the presentation. The Annex also includes the draft agenda for the workshop.

With regard to the logistics of the meeting, we would request the ability to project our presentations on a screen or TV monitor and a strong internet connection so we can have our specialists from China present specific solutions. We have proposed an 11am start to the workshop with a lunch break; we should be honored to host the lunch with an outside caterer. We shall be available later in the week for follow up meetings on specific solutions and can also arrange for further remote demonstrations by technical experts from China, when needed. We look forward to your kind reply.
